All Audit Adjustment have been done and received confirmation from the auditors that our balance sheet matches theirs. On Friday last week the updated PER report was submitted to the USDA. Also emailed all council a copy of it. Updated prices for Phase 1 is \$24.5 Million Phase 2 is \$14.6 Million. 2026 Capital Budgeting was turned into the state for bonding if we are awarded bonds from USDA. Clerk will setup a Public Hearing for the infrastructure update. Discussion on the Rural District percent.

Council Member Krumwiede had concern that a council member was seen driving the ToolCat. Was informed that no one else has ever driven the Toolcat other than a City Employees. Clarification from insurance company, Council can't drive equipment other than for city business, under direction and control of a city employee and have had our safety training. Might be good for some council members to get some training. Mayor Kuehl would like each council member & department to start working on their budget. Martin County Sheriff will be \$87.50 for a dedicated officer an hour. Motion made by Council Member Bradford Flohrs, seconded by Council Member Justin Lubben. Motion carried to approve Sheriff coverage for FunFest. 5-0 Facebook would have notices are they on our website. Anyone can sign up for it. Citizens can call city hall if they need help getting signed up. Citizen Nikki Indergaard said she didn't get the alerts. Tyler Kettner wondering about where his complaint is at that he put in. Carol Brandt wondering if her neighbor could get her stop sign moved over. Lois Schultz wondering what started all of this with Borntrager's. Council Member Krumwiede discussion on how long we will keep out a temp meter.
